Homeless and Panhandlers

Homelessness and panhandling are not crimes.

If you don't feel comfortable asking people who may be loitering or blocking entryways to leave, the next step can be a call to the Sheriff's non-emergency dispatch at 858.565.5200.

Trespassing is a crime. Panhandling can be a crime only if it is aggressive. If someone feels threatened, is touched, or lunged at by a panhandler, it can be construed as aggressive.

In any case where you feel threatened or unsafe, do not engage, let law enforcement do their job.

When to Call 911 vs. Sheriff Dispatch

If any of these are happening in your parking lot or on your property, call 911:

Fighting, illegal drug use/sales, car theft/burglary in progress, graffiti in progress, brandishing weapons, threats of violence, robbery, carjacking, or **any felony crime in progress.**

The following are appropriate situations to call the **Sheriff's non-emergency dispatch at 858.565.5200...**

Aggressive panhandling, trespassing, loitering, alcohol use in parking lot, new graffiti or vandalism (not in progress).

Got Security?

Contact the Sheriff Rancho San Diego Substation at 619.660.7090 and ask for a crime prevention specialist to arrange a free site survey of your business or commercial property. You will get recommendations for security specific to your business and situation.

The Crime Free Multi-Housing program is also available: current San Diego County Sheriff contacts are Nancy Ortiz and Taylor Linhart.

Graffiti Abatement

You are responsible for removing graffiti on your property. The sooner you do, the less likely it is that you will be tagged again. If you report it to the Sheriff's Dept. they can document the graffiti for possible future prosecution.

If you see graffiti on county property or along roadways, you can call the authorities. If it's along the highway, call the Caltrans Graffiti Hotline at 619.688.6699. If county property is tagged (such as culverts or county roads) call SD County Code Compliance at 858.694.2705

Crime & Trash at Your Backdoor?

There can be some unwanted activities going on in the alley behind your business. However, there are a few things you can do to reduce this:

- Report crime or suspicious activity to the Sheriff at 858.565.5200
- Keep it clean. If the back of your business is clean, it's more likely to stay that way. If it looks like a dump, it will invite more dumping.
- Lock all dumpsters if possible. This discourages illicit activity and reduces excess trash.

After-Hours Trespassing

Once your business is closed for the day (or days you are closed) anyone on your property can be cited for trespassing if you meet certain criteria:

You must file a Trespass Letter with the Sheriff's Dept. that states you as the business or property owner want anyone found on the property after hours removed. This gives consent for a deputy to ask someone to leave, and arrest/cite them if they refuse.

Abandoned Vehicles

If a vehicle has been sitting in your parking lot for a few days, it's bad for business and invites more abandonment. You may want to have a general towing authorization agreement with a local towing company to handle this. The vehicle owner can sue you if the towing is done improperly.

To make a legal tow, you must have tow-away notices or signs that comply with California Vehicle Code 22658. You will need to issue a notice on the vehicle asking that it be removed and then wait 96 hours before towing. However, the tow can happen 24 hours after notice is posted if the vehicle is missing major parts and is obviously abandoned or has expired plates.

It is recommended that you take a picture of the vehicle (with license plate and tow-away signage showing) as a record which may help you later if there is a dispute.

If the vehicle in question is parked on a public road, call the California Highway Patrol's El Cajon office at 619.401.2000

Vehicles parked on public roads in an intersection or a crosswalk, within 15 feet of a fire hydrant, on a sidewalk, in a bus stop, and in front of a driveway can be removed immediately via a call to the CHP. ⁷

Potholes

If you have a pothole on the road near your business, it can discourage customers from visiting your establishment. A quick phone call to the County can make all the difference.

You can also use the SD County Tell Us Now app on your Android or iPhone to report potholes and other county-related issues.





Note: Potholes in the parking lot of a

business are the responsibility of the property owner.

Lost Pets & Feral Animals

Lost pets running around your parking lot? The safest solution is to call County Department of Animal Services. This will ensure the safety of the animals and possibly reunite an owner with their pet.

Cats: There are no pickup services for lost or feral cats in Casa de Oro.

As of July 1, 2018 The County's Department of Animal Services only provides services to the residents and animals within the unincorporated portion of the County at its two shelters in Carlsbad and Bonita

However, you can drop them off at the Bonita Animal Shelter: 5821 Sweetwater Road, Bonita, 91902 619.767.2675

Dogs: After you check for tags (call the number of the owner if on the tag) have a description ready when you call the Animal Services at 619.767.2675

Dead animals on county roads (such as Campo Road) are handled by a contractor. Call the Rancho San Diego Sheriff Substation at 619.660.7090 for this service to be dispatched.

Note: Dead animals on private property are the landlord's responsibility.

Prepare Your Business for an Emergency

The financial cost of rebuilding a business after a disaster can be overwhelming. However, with a business continuity plan in place, you will be able to rebound and reopen quickly. You'll be in a better position to contribute to the economic recovery of your community.

- 1. Establish a protocol to communicate with employees outside of the office to ensure they and their families are safe. Test the procedures regularly.
- 2. Keep your plan and all related documents in a digital format or in an accessible, protected, off-site location.
- 3. Review your insurance coverage. Contact your insurance agent to find out if your coverage is right for your business. Make sure you understand the policy limits and deductibles. Ask about business interruption insurance, which compensates you for lost income and covers operating expenses if your company has to temporarily shut down after a disaster.
- 4. Establish a solid supply chain. If your vital vendors and suppliers are local and the disaster is widespread, you will all be in the same situation struggling to recover. Set yourself up to be able to get key supplies from companies outside your area, if possible. Create a contact list for important contractors and vendors you plan to use in an emergency. Make sure you know your suppliers' recovery plans.

Health & Safety

All businesses with employees are required to comply with state and federal regulations regarding the protection of employees. The Occupational Safety and Health Administration provides information on the specific health and safety standards. More info:

Health Insurance

Under the Affordable Care Act (ACA), businesses with 50 or more fulltime employees are required to provided health coverage or face a financial penalty. In most cases, the employer is required to pay around 50% of the cost of the insurance, with the rest to be paid by the employee. The employer contribution can vary, as the employee's contribution cannot exceed 9.66% of that employee's annual household income.

Businesses with 25 or fewer employees are not required to provide health insurance. However, businesses that offer it to employees and meet certain standards can earn tax credits. www.irs.gov/affordable-care-act/employers or www.coveredca.com/forsmallbusiness

Workers' Compensation Insurance

Even if you have only one employee you are required to provide Workers' Compensation Insurance. The fines are steep if there is an injured employee and you don't have it.

Americans with Disabilities Act

With a few exceptions, you will need to make sure your business is ADA compliant. It's good for your disabled customers and compliance avoids lawsuits. Contact the ADA if you need help determining your compliance to responsibility.

Landlord Specific

The landlord-tenant relationship can be complex and laws are frequently changing.

A very useful guidebook is produced by the California Department of Consumer Affairs. The "California Tenants Guide" can be found online.

It covers everything from how to disclose lead content, checklists for move in and out, along with most laws and regulations that landlords and tenants must abide by, including information regarding legal rent increases and eviction.

This is also a good document to cite if your tenant is not following the law or you have a minor dispute. It also provides information for first time landlords and a checklist of how to ensure you are following the law.

Fixing things before you rent will help you comply with Civil Code §1941.1 and Health and Safety Code §17920.3. It will also set you up for success with the landlord-tenant relationship. Happy tenants in well-maintained facilities tend to pay on time, have more respect for your property and encourages tenant longevity.


