President's Report

- a. Campo Road Corridor Revitalization Specific Plan Lisa and Bob spoke at the Board of Supervisor's hearing on January 11th. As of the time this report was written (4pm Monday Jan 9th), there were 57 e-comments in support of the plan and 1 e-comment opposed to the plan.
- b. Casa de Oro Library Abbey Reuter says things are progressing and that there will be an announcement that can be shared at the end of January.
- c. Supervisor Fletcher staff change Abbey Reuter is transitioning to a policy role and on February 1st we will have a new community liaison named Lauren. She has worked for the Supervisor for 2 years as the chair's assistant which involved creating proclamations and supporting the BOS chair in preparation of the supervisor meetings, so she is very knowledgeable about a broad range of topics. Abbey will still be working with us on projects related to land use, environment and youth issues as Policy Associate at Nathan Fletcher's office.
- d. "Coat Casa de Oro with Love" coat drive has collected approximately 75 coats, jackets and sweatshirts. Approximately 50 coats/jackets have already been donated to Father Joes. At the end of the drive, the child and youth size items will be delivered to Casa de Oro Elementary, Spring Valley Academy and Monte Vista High School
- e. The final paperwork has been processed by the county for the new CE grant that was approved by the BOS in September. We expect to receive the check for \$20,000 at the end of January.
- f. GMIA Walk to the Top Jan 7 Lots of people stopped at the CDOA booth! I promoted the Coat Drive and the monthly Community Clean Ups and asked people to send in an e-comment regarding the specific plan. I collected the following suggestions for what the community wants to see in Casa de Oro: Live music events, block party, craft shows and markets, farmer's market, community flea market, coffee & cars meet up, car shows, seasonal market and/or festival, community/park meet ups & live music, band parade and review, restaurant meet ups, use free high school talent to paint utility boxes, calm/nice family lounges, more lactose-free ice cream shops.
